






### MESSAGE FROM VBOB PRESIDENT

As the membership of the Veterans of the Battle of the Bulge edges toward the two thousand mark in our initial year, we should ask ourselves who we are and where we are going.

Our membership consists of ground and air veterans of the Bulge (about 94% of the total), associate members, and a unit member. Most of the veterans were with small fighting units; the others, with higher head-quarters. The associates are other World War II veterans, members of families of veterans, and those interested in the Bulge.

We are from all walks of life.

The veterans range in age from the mid 50's to the early 90's and the average age is around 61; most of the States are represented. The associates, from many States and several European countries, have a 15-to-60-plus year-old spread.

The proud and dedicated members of this strong international base will determine what the VBOB future will be.

The establishment of a Museum and Library will be a major contribution to world military history; past and future writings and other contributions of VBOB members will strengthen its value. Our commemorative postage stamp and the musical composition with multi-national tunes and a distinctive Bulge theme will live forever. Trips to the Ardennes will renew old friendships and result in new ones.



# VBOB PARTICIPATES IN CEREMONY AT ARLINGTON CEMETERY

Side by side with the major veteran organizations, the Veterans of the Battle of the Bulge were duly represented in the most important Memorial Day ceremony held in the United States. Participation in the wreath laying at the Tomb of the Unknown Soldier was the first public appearance of VBOB in a formal public ceremony. Other veteran organizations such as the American Legion, VFW, DAV, Military Order of the Purple Heart, AMVETS, Marine Corps League, Jewish War Veterans, Air Force Sergeant's Association, Women's Army Corps Association and thirty one other organizations participated in the ceremony at Arlington National Cemetery in Arlington, Va.

President Clyde Boden, 84th DIV. and Vice President of Military Affairs, Gene Drouillard, 75th DIV. represented VBOB. In taking part in this beautiful ceremony Clyde stated that he had "a feeling of remembering and a great pride for our country and for those who were being honored on that day". Gene mentioned that he had never realized that Memorial Day meant so much to him and that he sensed a sadness for our departed comrades who gave so much to keep our country great".

President Ronald Reagan also laid a wreath at the Tomb of the Unknown Soldier and made a speech in the Amphitheater. It was the first time that an American President has done both in the past fifteen years.

### HOW THE MEMBERS FEEL ABOUT VBOB

We have received many letters from our members regarding their feelings towards our organization. Since there were so many, and it would take many pages of the "Bulge Bugle" to quote them all, we have selected one letter that we feel tells it very well.

### BULGE STUDY GROUP IN LUXEMBOURG

"Cercle d'etudes sur las Bataille des Ardennes" is the official name of an organization in Luxembourg which is translated into English as the Circle of Studies of the Battle of the Ardennes. The short version is CEBA.

The organization is devoted to the study and maintenance of the history of the Battle of the Bulge. CEBA plans to erect a monument to the unknown GI of the Battle of the Bulge.

CEBA Historian Jean Milmeister reports they are happy to welcome veterans who fought in Luxembourg during the Battle of the Bulge. In a letter to VBOB member Demetri Paris (9th AD), he wrote: "Last week I had the visit of a veteran of the 28th Infantry Division and we found the place where he was captured by the Germans 38 years ago. It was a tremendous experience."

Milmeister reports that not all the staff members of CEBA speak fluent English but every member would be glad to help visiting American veterans. His invitation is addressed "...especially those (veterans) of the 4th, 5th, 8th, 26th, 28th, 35th, 76th, 80th, 83rd, 87th and 90th Infantry Divisions; the 4th, 5th, 6th, 9th, 10th and 11th Armored Divisions and the 17th Airborne Division."

### NEW BENEFITS FOR FORMER POW'S

On August 14, 1981, President Reagan signed Public Law 93-37, known as the "Former Prisoners of War Benefits Act of 1981", expanding VA eligibility for thousands of former prisoners of war. The former POW incarceration period was reduced from 6 months to 30 days, a presumption of service connection was established for certain disabilities resulting from malnutrition, and service connected benefits were allowed for psychosis and anxiety states regardless of when first shown unless there is an intercurrent cause. In addition, former POW's are now to be provided both inpatient and outpatient madical treatment on a priority basis, and their concerns are to be considered by an advisory committee to the Administrator.

If any VBOB member believes that he fits this category, it is suggested that he contact his nearest VA office. The VA wants to explain this new legislation to you. The information they need is: your name, address and phone number, your VA claim number; Social Security number and whether or not you are presently receiving VA benefits.

In addition to the above, we are advised that the State of Virginia recently reenacted Act 46.1-105.7 which provides former PCW's with special county and state license plates upon providing they were,

in fact, incarcerated during any war and received an honorable discharge.

There are other states that are following Virginia's trend, so we suggest that all former POW's contact their local municipal and state Departments of Motor Vehicles.

### BULGE MONUMENT PLANNED

Cercle d'études sur las Bataille des Ardennes (CEBA) may be translated as the Circle of Studies for the Battle of the Ardennes. This is a group in Luxembourg devoted to the study and preservation of the history of the Battle of the Bulge. They have volunteered their services to those VBOB veterans who return to visit the Ardennes, specifically those who visit Luxembourg.

The CEBA staff has announced they will erect a monument to the Unknown GI of the Battle of the Bulge in Clervaux. At the base of the monument will be the insignia (badges) of the units who fought in Luxembourg and liberated it from the German attack and occupation.

The monument will be dedicated on September 11, 1983. The CEBA staff hopes a number of veterans will attend the ceremony.

### STARS AND STRIPES CELEBRATES

The Stars and Stripes newspaper celebrated its fortieth anniversary last April. This tabloid was the unofficial publication of the United States armed forces in Europe. Most of us depended on it to find out how the war was going and how the major athletic teams were doing back in the states.

As a commemorative, Stars and Stripes published a collection of WWII cartoons. The first printing was 5,000 copies, which were sold within two weeks. More have been printed since that time, so more copies should be available. 28TH DIVISION APPOINTS VBOB REP.

A stone monument in honor of Americans who fought and died in and around Osweiler, Luxembourg, was unveiled on May 9, 1982. It bears the inscription, "Many gave their lives so that we can live in freedom. We the living must ensure that they have not died in vain."



The monument contains a plaque with the coat of arms of the United States, another plaque that recognizes the soldiers who liberated and defended the area from September 1944 to March 1945, and emblems of American divisions, all of whom fought in the Battle of the Bulge: 5th and 9th Armored and 4th, 5th, 28th, 76th, 83rd, and 87th Infantry.

Fred Karen, coordinator for the ceremonies and VBOB enthusiast, said the monument represents a continual reminder that
can be passed on to the young "of the
sacrifices of the American military in
World War II during the dark days of the
Ardennes offensive."

The dedicatory program, which contains historical and other information, sketches, charts, and maps, along with items in the Stars and Stripes and photographs, have become part of the VBOB Museum and Library.

The National Historian of the 28th Infantry Division, Edward W. Parks, has been appointed the division's representative to VBOB. A founding member of VBOB, Ed lives at Miller St., RFD #4, Middleboro, Mass. 02346.

Other major and separate units are expected to designate a unit representative to VBOB.

### LIBRARY AND MUSEUM ACQUISITIONS

In response to the request in the January newsletter for items of interest for our museum and archives/library, members have been sending in unit histories, photographs, newsletters, books, personal recollections, etc. So that nothing will be lost, the president felt that procedures for recording, cataloguing, and preserving these acquisitions should be set up immediately. He called a meeting for this purpose on April 29, 1982, at Fort Myer, with five members (Clyde Boden, Bill Hemphill, Ray Evans, Joe Langbart and Frances Doherty) present. And attending, to give us their expert advice, were Marie Langbart, librarian with the Government Printing Office, and David Langbart, archivist with the National Archives.

David will work out a system for cataloguing and preserving the acquisitions by subject and military unit; and also for preserving VBOB's own records and publications. He suggested that all papers should be kept in legal-size file folders, in storage boxes, and should be kept together in one holding area until we have a permanent library. Examples of various categories of paper were turned over to David for study. In the meantime, I hope our members will continue to send in written accounts and memorabilia pertaining to the Battle of the Bulge.

### M \* A \* S \* H

Charter Member Mary Hatcher Myers (128th Evacuation Hospital) served with the combat medical surgical hospital credited with being the original mobile army surgical hospital (M\*A\*S\*H), now a well-known TV series.

She entered the Army in March 1941 as a Red Cross Nurse and served with Army units in Africa, Sicily, England, and Europe. Mary earned four battle stars, including one for the Ardennes Campaign.

### LOGOTYPE ADOPTED

At their quarterly meeting on May 8, 1982, the Executive Council adopted the official logotype representing the Veterans of the Battle of the Bulge.

An original design conceived by a VBOB member served as the basis for the heraldic art work which was studied by a seven member committee. The Council approved their recommendations.

The logo is circular and includes the infantry blue, the armor yellow and the artillery red colors of the combat arms. A rifle and steel helmet are positioned in the center. The lower portion has a tank track, artillery gun tube and a lightning bolt.

The right side is a blue sky with silhouttes of a parachute and airplane. The left is green with the snow covered evergreen trees of the Ardennes Forest. The word "ARDENNES" appears at the bottom of the logo.

An impressive element is the single, brilliant star of Christmas, 1944 with its rays reaching down to all portions of the logo.

It is expected that the completed logo will be printed by October 1st. Other applications and uses will be developed.

VBOB members are invited to suggest future uses after you have seen it.

### FLASH REPORT ON THE EXECUTIVE COUNCIL MEETING OF 25 SEPT. 1982

The meeting of the Executive Council was called to order by Clyde Boden. Council and non-voting visiting members were welcomed and introduced by Mr. Boden.

Reports made and actions taken are as follows:

APPOINTMENTS/ Clyde Boden

Reverend George Hall -- Chaplain
Pete Dounis -- Chairman of the Nominating Committee vice Joe Langbart

MEMBERSHIP / Bob VanHouten -- As of 25 September VBOB has 1670 Members of whom 1587 are veterans,83 are associates and one is a unit membership.

FINANCES / Bob VanHouten for Bill Hemphill -- As of 31 August 1982, VBOB has assets of \$6,544.42 and no liabilities. Application of Recognition for Tax Exemption was submitted to IRS. The 1983 and 1984 budgets are being developed.

VBOB EMBLEM (LOGO) / Dee Paris -- The VBOB Emblem is currently in the hand of the artist. It will be completed before the general membership meeting in December of this year.

COMMEMORATIVE POSTAGE STAMP / Kipp De Angelis — On completion of color prints of the VBOB Emblem a formal recommendation will be transmitted to the Chairman of the Citizen Stamp Advisory Committee for issuance of a stamp on 16 December 1984 commemorating the 40th anniversary of the Battle of the Bulge.

GENERAL MEMBERSHIP MEETING / Bill Greenville -- Arrangements for the general membership meeting to be held in the Washington, DC area on 15, 16, 17 December 1982 are proceeding. An article and pullout concerning the meeting will appear in the next issue of the BULGE BUGLE. In addition press releases will be provided to veterans publications and newspapers.

VBOB TOUR OF THE ARDENNES BATTLE AREA / Kipp De Angelis -- Plans are proceding for a tour by VBOB members of the battle area in 1984. The plan will be presented to the Executive Council prior to the general meeting.

MUSEUM AND LIBRARY / Frances Doherty for Ray Evans and Dave Ruby -- A number of unit histories, photographs, personal histories etc., were recieved. Mr. David Langbart, son of Joe Langbart and an Archivist with the National Archives, established procedures for logging and filing the large volumn of Bulge related documents expected to be recieved by VBOB over the years.

MUSICAL COMPOSITION / Earl Meyers for Charles MacDonald — Charles MacDonald (military author and historian) and Dr. Harold Arberg (composer of "The Army Goes Rolling Along") were designated as VBOB points of contact with the U. S. Army Band for military and musical matters. A musical composition commemorating the Battle of the Bulge is planned for completion and presentation in 1984.

NATIONAL SALUTE TO VIETNAM VETERANS / Gene Drouillard -- No formal VBOB participation is planned for this November 11th, however, individual members are encouraged to participate.

VBOB FLYER / John Campbell — A VBOB flyer is scheduled for release in December of this year. The flyer will state the VBOB objectives and future.

BROCHURE / Bud Leinbaugh -- Quotes for reprinting the VBOR Brochure are being solicited. It is scheduled for completion in October.

INCORPORATION / Joe Langbart — No formal action toward incorporation has been taken as yet. Pros and cons on the advisibility of incorporation were discussed.

RELATIONSHIP TO UNIT ASSOCIATIONS / Gene Drouillard — Tentative criteria were established for VBOB formal involvements in unit association visits to the DC area.

THE BULGE BUGLE / Lucky Loiacono — The cut-off date for articles (this issue will contain approximately 30) is 2 October 1982.after which it will go to the printer. Printing will require 2 or 3 weeks.

CONSTITUTION / Joe Langbart — Most Articles of the Constitution were adopted. One was referred back to the committee for reworking. Joe was given a vote of appreciation for the time and effort he spent in preparing the Constitution.

Chapter Three Awards Dinner in Annapolis, Maryland, attended by 200 members and their distinguished guests, Clyde Boden, VBOB founder and current president, presented to former sergeant, Neil B. Thompson, his awards of the Presidential Unit Citation and Belgian Fourragere for service above and beyond the call of duty with the 740th (Daredevil) Tank Battalion. This action took place against numerous enemy forces during the Battle of the Bulge. Mr. Thompson is a past officer of the D.A.V., Department of Maryland, a Past Commander of Chapter Three and is presently a member of the VBOB Executive Council. GEN. McAULIFFE REMEMBERED

The Allied Airborne Association conducted a memorial service at Arlington National Cemetery for Gen. Anthony C. McAuliffe on Wednesday, August 11, 1982, the seventh anniversary of his death.

Following the posting of colors by the 3rd Infantry ("Old Guard"), Frank Juliano (101st Abn Div), association president, led the pledge of allegiance and spoke. Clyde Boden (84th Inf Div), president of the Veterans of the Battle of the Bulge, recited the 23rd Psalm.

Maj. Gen. Louis Menetrey (1st Inf Div and 101st Abn Div), now assigned to the Army Staff, and Jim Malloy (101st Abn Div) placed a wreath at the graveside. The ceremony was concluded with the playing of "Taps".

Gen. McAuliffe assumed command of the 101st Airborne Division in the absence of Gen. Maxwell Taylor, during the Battle of the Bulge in World War II when the division, along with other units was surrounded in Bastogne, Belgium. His reply to the German demand for surrender, "Nuts!", won the hearts of the free world in those dark days of December 1944.

A similar annual tribute is planned for August 1983.

The 2nd Battalion, 37th Armor, now a unit of the 1st Armored Division in Germany, is well aware of the role of the 37th Tank Battalion, its progenitor, and 4th Armored Division in the Battle of the Bulge, according to 1st Lt. Clair E. Conzelman, the S-2, Company "C", 37th Tank Battalion, was the first unit to break through to the encircled units of the 9th and 10th Armored and the 101st Airborne Division in Bastogne, Belgium. Company "C" was awarded the Presidential Unit Citation for this action. The personal experiences of veterans of this tank unit are being used for training purposes in the present day army.

ARMOR magazine's feature article in the November-December 1981 issue was titled "Breakthrough to Bastogne" which gave the account of the 4th Armored Division's breaking through the German ring.

Fourth Armored Division veterans Jimmie Leach, Company "B", 37th Tank, Pat Saussol, Company "C", 37th Tank and 35 other former members of the division are VBOB charter members.

As a footnote, we would like to add the fact that the 1st Battalion, 54th Infantry, a descendant unit from one of the 10th Armored Division's armored infantry battalions, is also in the 1st Armored Division. The 54th Armored Infantry Battalion was one of the encircled units in Bastogne and was your editor's outfit and I would like to take this opportunity to thank the men of the 37th Tank Battalion for getting us out of that situation.

President Clyde Boden appointed as chaplain The Reverend George W. Hall, Jr., whose current duties include serving on the Biblical Counseling staff of Truro Episcopal Church in Fairfax, Virginia.

During WWII George Hall was with the 94th Division, 302nd Infantry Regiment 2nd Battalion Medical Detachment. He served in the ETO in Brittany, Normandy, Ardennes and Germany. While in that capacity as a medic, he received two Purple Hearts and the Medical Corp Valour Award.

It is an honor to have him as leader of our spiritual needs.

### "DEATH OF A DIVISION" By Charles Whiting - Stein & Day, 1981

This book review is by Francis H. Aspinall of the 589th F.A. Bn., 106th Infantry Division. The "Bulge Bugle" neither confirms nor denies the contents of the review. Comments should be forwarded to the reviewer at 120 Nellwood Dr., Ponchatoula, LA 70454.

Mr. Whiting's DEATH OF A DIVISION is an interesting, spirited, account of a part of the experience of the 106th Infantry Division on and around the German SCHNEE EIFEL in December 1944. That, however, is the best that can be said for his version of the most painful disaster to befall American arms in Europe in WWII.

Perhaps Whiting's failure to come to grips with objectivity can best be understood in his (page 99) comparison of the British First Airborne Division at ARNHEM with the "shameful" failure of the 422nd and 423rd Regiments to break out of their SCHNEE EIFEL trap. His thesis seems to be that if a battle scarred division, with years of experience, trained to fight while surrounded, during an offensive operation, can break out of encirclement then a division whose members first heard a gun fired in anger, a week previous, must do the same thing or forever suffer a "shameful disgrace"!

Whiting reinforces this judgement on page 77 by saying:

"When the choice was finally between surrender and death Colonels Descheneaux (422nd) and Cavender (423rd) both chose the former."

.....But this is the stuff of which military "fairy tales" are constructed by men whose military experience is limited to a half dozen Grade B war movies!!.....shades of APPOMATTOX, BATAAN, and SAIGON!

The biggest military "failure" (and I think it cannot be called that) was the route of the 14th Cavalry Group on the Division's north flank which laid bare its access road, communications, and rear area. While this unit was under the command of General Jones (106th) he had (probably) never heard of it until a week before the big attack. Yet its "failure" is laid at the door of the 106th by Whiting (and others).

The author also tells us (page 16) that the 14th Cavalry with "exactly 900 men, strung out over 4 miles", occupied 7 village strong points. This force, of 225 men per mile, was attacked on Dec. 16th by 1 Parachute, 1 Armored, and 1 Infantry Division (40,000 men). Whiting apparently wishes us to believe that a "one man hockey team" should delay or stop a 40 man team!!...and he acts disappointed that they didn't. Why is he not satisfied to say that the 14th Cavalry was scattered "like chaff before the wind", and let it go at that?

Mr. Whiting fails to point out that in the LOSHEIM GAP (a natural defensive weak spot) VIII Corps had deployed 225 men per mile while adjacent to it in the 422nd, 423rd sector, in terrain non negotiable by armor, the "big brass" had deployed 6000 men over a 5 mile front (1100 defenders per mile). Significantly all history agrees that Gen. Jones had no part in, or responsibility for, this mis-deployment.

This author is unsparing in his criticism of Jones in particular, and 106th leadership in general. Page 58:

"Jones made a decision. He knew that up to now he had made all the wrong ones. He should have been more aggressive right from the beginning; then when he had realized that the situation in the Snow Eifel was beyond help, he should have ordered his men to pull back. The result was that he had lost his two regiments - and his son."

If Jones fouled things up so badly should not this "Monday morning" critic offer suggestion(s) as to what he (Whiting) would have done on Dec. 16 and 17....KNOWING WHAT JONES, CAVENDER, AND DESCHENEAUZ KNEW AT THAT MOMENT? Surely it requires little courage, imagination, or ability merely to criticize military decisions when the critic knows in advance what is going to (or did) happen!!

Finally author Whiting seems to have taken a certain amount of pains to exclude positive and include negative documentation and/or events. For example, in his introduction, he has the 589th FA not retreating or withdrawing, but "fleeing" down the road from Schonberg to St. Vith. Whiting omits completely that Major Arthur C. Parker III and his Battalion were "fleeing" toward an appointment at the crossroads of BARAQUE deFRAITURE, where for 5 days, they held the enemy off the right flank of an American Army, earned

a multitude of individual decorations, and a French Croix de Guerre for the Battalion.!

Why did he forget the 424th Regiment (a third of the Division)? This outfit, though badly mauled on December 16th held together and formed a key element in the defense of St. Vith and the "fortified goose-egg" from the 17th to the 22nd.

I could find not a word about Col. Riggs and his (organic) 81st Engineers who, the afternoon of the 17th, stopped the 18th VG Division on the doorstep of St. Vith...before the 7th Armored could get there. For that they earned a Distinguished Unit Citation but no credit at all from the author of "DEATH OF A DIVISION".
